**Explanation of Responses:**

- Each share of Series A Redeemable Convertible Preferred Stock will automatically convert into one share of common stock on May 8, 2015.
- The 2014 Convertible Notes will automatically convert into shares of Series A Preferred Stock on May 8, 2015 at a conversion rate of one share of Series A Preferred Stock for every \$1.00 of principal converted. Each share of Series A Preferred Stock will automatically convert into one share of common stock on May 8, 2015.
- The 2015 Convertible Notes will convert into Series A Preferred Stock on May 8, 2015 at a conversion rate of 1.25 shares of Series A Preferred Stock for each \$1.00 of principal converted. Each share of Series A Preferred stock will automatically convert into one share of common stock on May 8, 2015.

**Remarks:**

This Form 3 is filed jointly by Versant Ventures III, LLC ("Versant LLC"), Versant Venture Capital III, L.P. ("Versant Capital") and Versant Side Fund III, L.P. ("Versant Side Fund") (collectively, the "Reporting Persons"). Versant LLC is the sole general partner of Versant Capital and Versant Side Fund and has voting and dispositive power with respect to these shares. The individual managing members of Versant Ventures III, LLC are Brian G. Atwood, Bradley J. Bolzon, Samuel D. Colella, Ross A. Jaffe, William J. Link, Barbara N. Lubash, Donald B. Milder, Rebecca B. Robertson, Robin L. Praeger and Charles M. Warden (collectively, the "Managing Members"), all of whom share voting and investment power with respect to these shares. Each individual Managing Member disclaims beneficial ownership of these shares, except to the extent of their pecuniary interest in such shares.
